

ARTIST AGREEMENT

1. This is a mutual agreement between the venues listed below and the undersigned artist. The artist agrees to display submitted artwork for an approximate period of two months, rotating bi-monthly, on the approximate 1st day of the rotation month.
2. Artists rotating into the Wimberley Village Library are responsible for completing and signing the Library's "AGREEMENT FOR LOAN OF PERSONAL PROPERTY", at the time of rotation, available at the Research Librarian's desk.
3. Venues currently participating are:
 - a. Ozona Bank, 101 River Road, Wimberley
 - b. Hackett Financial Group, 15577 RR12, Suite 106, Wimberley
 - c. Wimberley Visitor's Center, 14100 RR12, Wimberley
 - d. Wimberley Village Library, 400 FM2325, Wimberley
 - e. Wimberley Dental Center, 181 FM 3237, Wimberley
 - f. Wimberley Medical Plaza, 201 FM3237, Wimberley (entrance and lobby)
 - g. Office of Dr. Eric Price, 201 FM3237, Suite 111 (waiting room)
4. All sales will take place between the buyer and the artist. The artist is responsible for collecting 8.25% sales tax and reporting sales to the State of Texas. The artist will replace a sold work with a comparable piece as soon as possible. ***The artist agrees to immediately pay WVAL a 10% commission upon any sale. Send commission check(s), made payable to WVAL to WVAL, Treasurer, P.O. Box 1652, Wimberley, TX 78676.***
5. All artists who are engaged with other galleries are responsible for securing his/her release from that gallery.
6. Artist Release: The undersigned does for himself, herself, his and her heirs and assigns, hereby waive, release and discharge the Wimberley Valley Art League ("WVAL") and the venues cited above, their members or agents, from any and all manner of actions, suits, damages, claims and demands whatsoever, in law and equity for any loss or damage to the undersigned's property and for any personal liability.
7. Artist Release: The undersigned acknowledges and agrees that neither WVAL nor any above cited venue, their DIRECTORS, OFFICERS, AGENTS, EMPLOYEES, VOLUNTEERS or AGENTS will provide any security or protection for artwork and that their display will be at their sole risk.
8. Artist Release: The undersigned grants permission to WVAL , its agents or any above cited venue and their agents to photograph his or her artwork only for use in publicity.
9. Termination: The artist and WVAL may, at any time and for any reason, terminate this agreement with a 2 week prior written notice from either party.
- 10. Finally, the undersigned acknowledges that he or she has read and agrees to the terms as set forth in this Agreement.**
